UWEM has had a long standing focus on Food Security through programs like the FEMA Emergency Food & Shelter Program (EFSP), The National Association of Letter Carriers (NALC) Food Drive and UWEM's Pantry Project. We are committed to raising the resources necessary to meet the immediate Food Security Needs for our region while addressing the underlying causes of Hunger and working with partners to strengthen the Food Security Network. Last year our food collection efforts generated 151,612 pounds of food for those in need.
